CLUB RULES TO BE ADHERED TO BY MEMBERS & GUESTS

1. Membership identification should be carried at all times.

DRESS

2. Clean, neat & tidy dress to be worn at all times. Tops with offensive slogans and dirty work clothes (including footwear) are not permitted in the Club at any time. No bare feet allowed at any time. No Shirt, No Shoes, No Service.

CHILDREN

3. All children must be strictly SUPERVISED in the Club and on the grounds.
Children may be restricted from some functions in the Cabaret Area.
Children under the age of 18 years are not allowed on the Club premises unless accompanied by a parent or adult member or visitor in charge of the child.
No children under 18 years of age shall purchase alcohol or have it purchased for them.
Children are not permitted on Club premises after 11pm.
Children are not to be left unattended while parents are in the Gaming Room.

GENERAL

4. No Member or Visitor shall willfully damage Club property or indulge in indecent language or disorderly behaviour on Club property. Members may be held responsible for their guests.
5. No persons shall use unlawful drugs on the Club premises at any time.
6. The Club Manager or his delegate's decision shall be final for that time, but any appeal against that decision will be heard by the Management Committee if put in writing and addressed to the Secretary within seven (7) days. Members and Visitors must abide by and acknowledge any disciplinary action or correspondence received from the Club Management.
7. Gambling of an unauthorised nature is not allowed on Club premises.
8. Drinks of any type are not allowed to be brought onto the Club premises.
9. Food is not allowed to be brought onto premises without the permission of Management.
10. No animals allowed in the Club (except Guide Dogs for the Blind or Hearing Dogs).
11. All drinks must be finished 15 minutes after closing of the Bar.
All credits on poker machines must be taken before closing times.
12. No games or activities may be started after closing of the Bar.
13. The Club Carpark is one way, with a speed limit of 8 kph at all times.
14. No person under 18 years of age allowed in the Gaming Room.
15. As the Club is your host, we are responsible for your safety. If you are drunk, disorderly or offensive we will not serve you and you will be asked to leave.
16. Your membership card is your personal identification and is not transferable. Any breach of this rule could render your membership void.
17. Privacy Act: Members personal details held by the Club are used for Club mail-outs, membership financial status, birthday incentive scheme and for discounted drinks (name only) and will not be disclosed under any circumstances unless written consent is obtained or the disclosure is required or authorised by law.
